




NISHTAR MEDICAL UNIVERSITY, MULTAN
TENDER NOTICE

Sealed tenders are invited from the firms having established credentials in terms of financial and managerial capabilities and registered with income and sales tax departments, for the Purchase of Plant & Machinery Items (Heavy Duty Photocopier & Optical Mark Recognition) through Tender on FOR basis for the financial year 2021-22. Sale of tenders will be started from the date of publication of this advertisement in the press. The detail of items is as under:

1. Interested bidders may get the bidding document along with detailed specifications from the office of Purchase Officer Nishtar Medical University, Multan on submission of written application on letter head and a copy of CNIC along with payment of non-refundable fee of Rs.2,000/- (Two thousand only) for each item/package. The bidding documents can also be downloaded from the website www.ppra.punjab.gov.pk. Detailed specifications shall be issued as per advertisement given in PPRA and University Website.
2. 02% Bid Security shall be attached with the bid in the shape of Irrevocable Bank Guarantee or CDR from any scheduled bank in name of Vice Chancellor Nishtar Medical University, Multan otherwise bidding documents will be rejected.
3. Single Stage – Two Envelopes bidding procedure shall be applied. The envelopes shall be marked as “FINANCIAL PROPOSAL” AND TECHNICAL PROPOSAL” in bold and legible letters. Financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.
4. Procurements shall be governed under the Punjab Procurement Rules, 2014 amended up-to date.
5. Sealed bids are required to be brought in person by the authorized representative of the interested bidders. Bids can be submitted in Purchase Branch Nishtar Medical University, Multan, till **18-10-2021** before **11:00 AM**. The bids received till the stipulated date & time shall be opened on the same day at **11:30 AM** in the presence of the bidders or their authorized representatives by the Purchase Committee.
6. All bids should be submitted in tape or ring binding. All documents should contain proper page marking, attached in sequence as indicated for evaluation of bidding document and signatures of authorized person.
7. In case the date of opening or last date of sale of tender documents is declared as a public holiday by the government or non-working day due to any reason, the next official working day shall be deemed to be the date of sale, submission and opening of tenders accordingly. The time and venue shall remain the same.
8. All detail specifications including required items, their quantities and terms & conditions are contained in the bidding documents.
